- ❑ Employment Eligibility Verification (I-9 Form) – New staff, staff who have had a name change, and all those returning staff who were born in an odd number year i.e. 1951, 1991, etc. Be sure and bring the appropriate documents to the first staff meeting or make a copy and mail or fax it with your paperwork - **see instructor home page for form.**
- ❑ Parent/School Authorization (Minor Work Form) – **Staff under age 18 as of January 6, 2012 - see instructor home page for form.**

The form must be signed by your parents and school authority before you can work. *IN ADDITION...You also need a photo-copy of one of the following for your file:*

- a) Birth Certificate
- b) Driver's license
- c) Baptismal record
- d) Notarized statement from parent or legal guardian.

# How To Get Your Season Pass

First, your season pass is a privilege, and, as with all privileges, if you abuse it you will lose it. Please obey all area rules, regulations, and ski/board in a safe, responsible manner. The following are the procedures you will follow to be eligible for a season pass.

- You must complete all employment paperwork.
- You will then be issued a season pass application, if applicable, to the ski area where you are working. Some staff members may not be eligible for season passes at some ski areas.
- The ski area will assess a \$25 late fee for forms received after December 31, 2011.
- Any abuse of your season pass (or day tickets) constitutes theft and is grounds for immediate termination. You must show your pass or ticket each time you use a lift and at any time you are requested to do so by area personnel. Allowing someone else to use your pass or ticket is considered fraud and is grounds for immediate termination.
- If you leave employment of Ski Masters Ski School, Inc. prior to the end of your work assignment, you are required to return your season pass. There are no refunds for season passes. Failure to return your season pass constitutes theft and this information will be given to the ski area. You may then be charged full price for your pass plus any applicable fines.
